NOTICE is hereby given that the Cheshire West and Chester Borough Council proposes to make the following Traffic Regulation Orders in accordance with the provisions of the Road Traffic Regulation Act 1984.

**THE CHESHIRE WEST AND CHESTER BOROUGH COUNCIL  
(LITTLE NESTON WEST) (20MPH SPEED LIMIT) ORDER 2017**

The effect of the Order will be to introduce a 20 mph speed limit on the following lengths of road:  
The entire lengths of Steeple Court, Eldon Terrace, Church Lane, Beechways Drive, Allans Meadow, Allans Close, Grasmere Road, Flint Drive, Flint Close, Flint Meadow, Meadow Close, Thirlmere Road, Henley Road, Sutton Avenue, Henley Close, Arden Drive, West Drive, Wellesbourne Close, The Dale, Stratford Road, Leamington Close, Hampton Crescent, Hampton Close, Coniston Road, Avon Close, Kenilworth Road, Homecrofts, Warwick Close, Merton Close, Somerville Close, Cross Lane, Riverside Walk, Sandon Crescent, Quayside.  
Burton Road between its junction with Eldon Terrace and its junction with Allans Meadow.  
West Vale between its junction with Grasmere Road to its junction with Thirlmere Road.

**THE CHESHIRE WEST AND CHESTER BOROUGH COUNCIL  
(NESTON EAST) (20MPH SPEED LIMIT) ORDER 2017**

The effect of the Order will be to introduce a 20 mph speed limit on the following lengths of road:  
The entire lengths of Breezehill Road, Gunn Grove, Breezehill Park, Breezehill Close, Blackeys Lane, Highfield Road, Highfield Close, Tannery Lane, Gladstone Road, Olive Road, Olive Drive, Raby Park Close, Orchard Walk, Raby Gardens, Sytchcroft, Frobisher Road, Marlow Road, Jonson Road, Spenser Road, Shakespeare Road, Drake Road, Grenville Road, Raleigh Road, Hawkins Road, Sidney Road.  
Raby Park Road from a point 325 metres south west of its junction with A540 Chester High Road to its junction with Tannery Lane.  
Brook Street between its junction with Tannery Lane and its junction with the access road to Post Office sorting office and Sainsburys car park.  
Raby Road between its junction with Ladies Walk and its junction with Tannery Lane.

Full details of the proposals are in the draft Order which, together with a plan showing the extent of the proposal may be examined at Neston Library, Parkgate Road, Neston, Cheshire, CH64 6QE.
